# **Role of Research and Development Coordinator:**

- Taking efforts for improvising ranks in NIRF and other agencies;
- Support coordinator for conducting meeting, making, updating, and maintaining records related to research events and activities.

#### **Role of Students:**

- To stuck-up with research ethics;
- To engage in conducting quality research;
- To participate proactively in research events and activities;
- To utilize the research facilities available in HEIs by strictly following SOPs.





# **Role of Alumni:**

- Provide information on R&D, knowledge and skills required to work there;
- Support in improvising the collaborations with industries for running various consultancy type research projects;
- To make avail training opportunities in R&D to the students;
- Contribute in strengthening and up-gradation of research facilities.
- 6. Action Plan: Every year action plan of research and development cell 2022-2023
  - Constitute Research and Development Cell at the beginning of the academic year in consultation with the Head of the HEI;
  - Research and development cell meeting in every quarter of the year;

  - Participate in NIRF ranking;
  - To suggest and monitor activities of various committees/ units/ cells of the HEI.
